- How to look up Library of Congress and VIAF authority records for organizations in your university or anywhere
 - Go to http://authorities.loc.gov/cgi-bin/Pwebrecon.cgi?DB=local&PAGE=First and set the search type to "name authority headings"
 - Search for a department in your university (include your university name), click on the desired result, and look for a link called "Authority Record." results seem to vary depending on what entries catalogers have made
 - That record will have an identifier and list a URI e.g., http://lccn.loc.gov/n85232974
 - If you click on that link, look for a link on the resulting page that connects to the same record in VIAF, an international database maintained by OCLC and various national libraries – e.g., http://viaf.org/viaf/135574777
