In its current form, support for fixity in any form is entirely optional, it simply points out parts of the underlying HTTP Digest specification that might be relevant to systems that implement either transmission and/or persistence checks. If this is something that any part of the community relies upon then I think there will need to be an additional specification with a number of MUSTs, or it will end up being *de-facto* defined by a particular implementation.
